The organizations's parent activities are mainly focused on training, supporting, and providing resources for the subsidiary chapters, who deliver program services. A total of 8 staff persons support nearly 4,500 volunteer members. Staff also administers the scholarships for therapists program, which awarded 247 educational scholarships, as well as the Therapeutic Tricycle Program; which makes awards in all fifty states. Chapters reported an estimated 4,000 volunteers who provided 50,000 hours of community service. Chapters provided an estimated 2.1 million dollars in grants to programs. Additionally, chapters first accomplishment provided approximately 2,500 therapeutic bicycles to individuals with disabilities; nearly 55,000 since inception.
